



The Downtown San Jose Farmers' Market kicks off its 18th season May 7 and SJDA would like to offer you an opportunity to promote your business, association or organization through the **Merchant at the Market program**. The market is located on San Pedro Street, between Santa Clara and St. John streets, and is open Fridays 10 a.m.-2 p.m. through Dec. 17 (except Friday, July 2 and Friday, Nov. 26).

The Merchant at the Market program allows downtown Business Improvement District (B.I.D.) member businesses or organizations to set up displays, distribute giveaways, coupons, and information promoting their business and sell non-edible merchandise. A table and two chairs will be provided for all Merchant at the Market participants. Merchants are responsible for setting up and tearing down their own materials and each display is subject to SJDA's approval.

The 2010 participant fee is \$50 per week for businesses without non-profit status. NON-PROFIT organizations receive first-time free, then a discounted \$25 per week rate. (proof of non-profit status required for discount). All fees must be received four days in advance or you forfeit your space. No refunds will be given for cancellations made less than four business days.
